## Interpretation and Definitions

The words of which the initial letter is capitalized have meanings defined under the following conditions. For the purposes of this Cookies Policy, the following definitions shall have the same meaning regardless of whether they appear in singular or plural.

- **Company** (referred to as either "the Company", "We", "Us", or "Our" in this Cookies Policy) refers to XIPPIOS GmbH, Kiefernain 20 B in DE-25451 Quickborn.
- **Cookies** means small files that are placed on Your computer, mobile device, or any other device by a website, containing details of Your browsing history on that website among its many uses.
- **Website** refers to DERMASTUDY, accessible from <https://www.dermastudy.org>

- Administered by: Us

They help to authenticate users and prevent fraudulent use of user accounts. Without these Cookies, the services that You have asked for cannot be provided, and We only use these Cookies to provide You with those services.

### Cookies Policy Acceptance Cookies

- Type: Persistent Cookies
- Administered by: Us
- Purpose: These Cookies identify if users have accepted the use of cookies on the Website.

### Functionality Cookies

- Type: Persistent Cookies
- Administered by: Us
- Purpose: These Cookies allow Us to remember choices You make when You use the Website, such as remembering Your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter Your preferences every time You use the Website.
